As a part of our Factory Compliance Program, we conduct preliminary inspections of each new Tier 1 supplier facility and require detailed questionnaires from potential suppliers. We have an audit protocol under which audits of direct supplier facilities are conducted by an independent third-party auditor. Suppliers are selected for audits each year based on a risk assessment and the results of prior audits. Direct suppliers are subject to announced audits at least every three years and unannounced audits as the circumstances warrant.

Finished goods suppliers are considered Tier 1 suppliers. Tier 2 suppliers include fabric, trim and hardware suppliers and processing units, and Tier 3 suppliers include raw material suppliers. We strive to have 95% traceability of Tier 2 suppliers by 2025.

Priority non-conformance rate and associated corrective action rate for suppliers' labor code of conduct audits

CG-AA-430b.2

We require all direct suppliers to have a collaborative approach and commitment to resolving instances of non-compliance with our Factory Compliance Program standards prior to producing for our brands. We review all non-compliance issues with suppliers and require they be addressed in a timely manner. Audits in which issues are identified have corrective action plans that are later verified.

No zero-tolerance issues were identified in connection with any FY19 audit.

Of the corrective action plans issued and associated with FY19 audits, 15.6% dropped out of the remediation program due to sourcing decisions; 31.1% are currently in remediation; and 53.3% were remediated.
