ROYALTY CHECK INFORMATION

Terms used and their meanings:

- PRODUCTION DATE Calendar month that production of the "product" happened.
- 2 **PRODUCT** Would have one of the four following values:

GAS

PPROD (Plant Product or Processed Gas) — Natural gas liquids

ΛII

COND (Condensate) - Oil produced from a gas well

3 INTEREST TYPE — Typically, one of the two:

R1, R2, R3 - Royalty Owner W1, W2, W3 - Working Interest Owner

PRICE — Unit price received from purchases - unit of measure

Per Barrel for oil and condensate Per MCF (1,000 cubic feet) for natural gas

O DECK DCML/DIST DCML

1st Line which has the Gross amounts is 100% amounts 2nd Line which has Owner amounts is Owner's share equal to distribution decimal times 100%
