REVENUE CHECK INFORMATION

Terms used and their meanings:

- 1 **RENTS** — Amounts paid due to lease bonus, obligations, lease renewals or extensions
- 2 **ROYALTIES** — Gross royalties paid including production taxes.
- 3 **OTHER INCOME** — Amounts paid to surface owners due to surface damages or surface use.
- 4 **FEDERAL INCOME TAX WITHHELD**
- 5 **FISHING BOAT PROCEEDS**
- 6 **MEDICAL AND HEALTH CARE PAYMENTS**
- 7 **NONEMPLOYEE COMPENSATION**
- 8 **SUBSTITUTE PAYMENTS IN LIEU OF DIVIDENDS OR INTEREST**
- 10 **CROP INSURANCE PROCEEDS**
- 13 **EXCESS GOLDEN PARACHUTE PAYMENTS**
- 14 **GROSS PROCEEDS PAID TO AN ATTORNEY**
- 16 **STATE INCOME TAX WITHHELD**
- 17 **PRODUCTION TAXES** — This amount is the proportionate ownership share of lease tax as reflected on your revenue detail issued between January 1, and December 31, of the tax year.
- 18 **OTHER REVENUE DEDUCTIONS** — This amount is the proportionate ownership share of lease deducts as reflect on your revenue detail issued between January 1, and December 31, of the tax year. This does **NOT** include netted expenses (reflected with a deduct code of NE).
- 19 **NETTED JIB CHARGES** — Deductions from working interest owners.
- 20 **FEDERAL WITHHOLDING** — This amount is the federal backup withholding, which is most commonly withheld because your tax identification number was not on file at the time of payment.
- 21 **STATE WITHHOLDING** — This is the amount of state taxes withheld as required by New Mexico (non-resident), Oklahoma (non-resident), Montana (as required) and Utah (as required).
- 22 **NET REVENUE PAYMENTS MADE TO YOU** — This amount is the net revenue distributed to you on payments issued from January 1, to December 31, of the tax year. This does **NOT** include netted expenses.
