Accella adds a new platform for Carlisle bringing significant revenue and cost synergies to Carlisle Construction Materials (CCM), and creates the opportunity to pursue additional adjacencies within the \$15 billion global construction related polyurethane market. The acquisition of Accella contributes to CCM's well-established strategy of providing customers with high quality, innovative solutions for building envelope applications.
