- Utilize a governance structure with defined scope and management system to drive continuous improvement and accountability

All the above are based on a foundational framework of CSR pillars, providing an enterprise-wide structure to which all CSR efforts are aligned and measured for company and global community benefit

## **Reporting & Data Disclosure**

For transparency and to assist key stakeholders in their research of the company's ESG performance, Keysight provides annual disclosure data aligned with the General Reporting Initiative (GRI) and Sustainable Accounting Standards Board (SASB) reporting frameworks in the following formats:

- Annual CSR Report A comprehensive review of Keysight's CSR program and related functions, strategy, past fiscal year results, and GRI Standards and SASB Data Indexes. In addition, any disclosures related to Task Force on Climate-related Financial Disclosures (TCFD) are noted and referenced where applicable.
- Data Reports The GRI Standards Data Report, TCFD Data, and SASB disclosures provide disclosure data released by Keysight and aligned with these frameworks for easier search and retrieval of ESG data points of interest.



• DEI Report - As part of our focus on DEI and commitment to accountability, we publish an annual Diversity, Equity, and Inclusion report to share the work we are doing to enable every employee to thrive and Keysight to succeed.

In addition, Keysight submits data to, or verifies data provided by, the following ESG-related rating and ranking organizations, typically in the summer each year unless otherwise noted:
