



Conditions of Access to Ply Gem's Financial Information Website

Ply Gem Midco, Inc. ("Ply Gem") will make certain financial information and certain reports (the "Company Information") available in this virtual data room from time to time. Only the following individuals will be granted access to the Company Information:

- Current Holders of Notes;

- Market-making financial institutions reasonably satisfactory to Ply Gem, (collectively, "Permitted Parties").

Ply Gem will make the Company Information available to Permitted Parties, on a confidential basis, solely for evaluating investments in Ply Gem's 8.00% Senior Notes due 2026 (the "Senior Notes"), and Ply Gem will not make the Company Information available for any other purpose. The Company Information may not be copied, reproduced, retransmitted or conveyed in whole or in part without Ply Gem's prior consent. By selecting "Agree" at the bottom of this page, you agree to the restrictions set forth herein, acknowledge that the Company Information contains confidential information, and agree that the use of the Company Information for any purpose other than set forth above, or as otherwise permitted in writing by Ply Gem, is strictly prohibited and a violation of these conditions of access. You will keep the Company Information confidential. You agree that money damages would not be a sufficient remedy for breach of this agreement, and that Ply Gem will be entitled to equitable relief, including injunction and specific performance. The Company Information is current only as of its date. Ply Gem makes no undertaking to update any Company Information.
