The Freedom Award is sponsored by the National Committee for Employer Support of the Guard and Reserve (ESGR), an agency of the Department of Defense. Award recipients are nominated by their employees who voluntarily serve in the National Guard and Reserve.

Their only concern should be their service to our nation," said MGM MIRAGE Chairman and CEO Terry Lanni. As part of its benefits package, MGM MIRAGE provides employees who are deployed for military service with 100% of their base pay. Average tip income is also provided to eligible employees.
