# Trevali to be added to S&P/TSX Global Mining Index and S&P/TSX SmallCap Index

Vancouver, British Columbia...Trevali Mining Corporation (“Trevali” or the “Company”) (TSX: TV; BVL: TV; OTCQX: TREVF; Frankfurt: 4TI) will be added to the S&P/TSX Global Mining Index (including its subsets, the S&P/TSX Global Base Metals and Equal Weight Global Base Metals Indices) and to the S&P/TSX SmallCap Index effective after the close of trading on Friday, Sept. 19, 2014.

“Trevali has experienced significant growth over the past few years, graduating from explorer to developer to the only primary zinc producer on the TSX,” stated Dr. Mark Cruise, Trevali’s President and CEO. “We are proud of our inclusion in these S&P/TSX Indices as recognition of both our accomplishments and creation of shareholder value. Our addition to these indices should increase Trevali’s exposure to a broader range of both institutional and retail shareholders.”

In Canada, Trevali owns the Caribou mine and mill, Halfmile mine and Stratmat deposit all located in the Bathurst Mining Camp of northern New Brunswick. The Company is currently advancing its 3,000-tonne-per-day Caribou Mill Complex and mine towards scheduled 2015 production.

All of the Company's deposits remain open for expansion.
