RULES OF CONDUCT AND PROCEDURES FOR MEETING

Welcome to Fresh Del Monte Corporation's 2021 Annual General Meeting of Shareholders (Annual Meeting). It is our desire to conduct a fair and informative Annual Meeting. Kindly observe the following Rules of Conduct and Procedures:

1. The business of the Annual Meeting will be taken up as set forth in the Agenda.
2. The only business matters to be conducted at the Annual Meeting are the matters set forth in the Notice of Annual General Meeting of Shareholders and 2021 Proxy Statement dated March 23, 2021.
3. Only shareholders of record as of the close of business on March 10, 2021, the record date, or their duly authorized proxies, and beneficial owners as of the record date who have registered prior to the Annual Meeting and obtained a legal proxy are entitled to submit questions and vote at the Annual Meeting. Shareholders may vote until the polls close.
4. Persons wishing to enter the Annual Meeting as a guest in listen-only mode, must click on the "I am a guest" button after entering the Meeting Center site and enter the information requested on the following screen. Guests will not have the ability to make a statement, ask questions or vote during the Annual Meeting.
5. Shareholders of record and registered beneficial owners may vote their shares electronically during the Annual Meeting by clicking on the "Cast Your Vote" link on the Meeting Center site. If you have already voted your shares by sending in a proxy, or voted via telephone or internet, you do not need to take any further action.
6. Nominations made during the Annual Meeting for membership on the Board of Directors will not be accepted unless the shareholder has previously notified us in writing of the intent to make the nomination (following all procedures set forth in our Articles of Association), and the person nominated has given written consent to such nomination and agreed to serve if elected.
7. Beginning 15 minutes before and during the Annual Meeting, shareholders of record and registered beneficial owners may submit written questions or comments related to matters properly submitted before the Annual Meeting online by returning to the Meeting Center. Click on the "i" icon in the upper right corner to submit your question or comment.
8. Questions pertinent to meeting matters will be answered after the Proposals and Discussion portion of the meeting during the Q&A session, subject to time constraints.

9. We will respond to no more than two questions from any single shareholder of record or registered beneficial owner.
10. Answers to any pertinent questions not addressed during the Annual Meeting will be posted following the meeting on our website at <http://investorrelations.freshdelmonte.com/overview/default.aspx> under the heading—“Annual Meeting”.
11. Questions and answers will be grouped by topic and substantially similar questions will be answered only once.
12. Shareholders’ views, constructive comments, and criticisms are welcome, but the Chair will not address questions and will stop discussions that:
 - are not pertinent to matters properly submitted before the Annual Meeting;
 - are repetitious or have already been made by other persons;
 - relate to material non-public information of the Company;
 - are references to individuals or that are otherwise disrespectful;
 - relate to a personal grievance; or
 - are not a matter of interest to shareholders generally.
13. Additionally, the Chair will stop discussions relating to proposals that were not previously submitted properly under SEC Rule 14a-8 or in accordance with the advance notice provisions in our Articles of Association.
14. In the event of technical malfunction or other significant problem that disrupts the Annual Meeting, the Chair may adjourn, recess, or expedite the Annual Meeting, or take such other action that the Chair determines is appropriate in light of the circumstances.
15. Recording of the Annual Meeting is prohibited.
