

Community Contributions Policy

June 2017



I. Introduction and Purpose

Goldcorp's vision is "Together, creating sustainable value". Community contributions support this vision by enhancing social and economic development opportunities and creating lasting, positive impact in the communities where we work.

The purpose of the Community Contributions Policy is to establish requirements for contributions (donations, sponsorships, sustainability funds and investments) made in and/or with local communities, stakeholder groups and partners. All company contributions will align with Goldcorp's strategic objectives, benefit communities and aim to build trusting relationships. This policy is aligned with Goldcorp's Code of Conduct, Corporate Social Responsibility Policy, Human Rights Policy, Government Payments and Contributions Policy, Anti-Bribery and Anti-Corruption Policy and Sustainability Excellence Management System (SEMS).

II. Scope and Applicability

This policy applies to Goldcorp Inc., its wholly owned subsidiaries, board members, officers, employees, contractors or any third party that provide cash, in-kind, or time contributions on behalf of Goldcorp to local communities, stakeholder groups and partners. Goldcorp Inc. expects that each of its wholly owned subsidiaries will ensure compliance with this policy. The Executive Vice President, Corporate Affairs and Sustainability is responsible for compliance with and periodically updating this policy. Goldcorp's Board of Directors Sustainability Committee has oversight on the application of this policy.

III. Compliance Requirements

In order to achieve our vision of together, creating sustainable value and in alignment with our Six Pillars, Goldcorp makes the following commitments:

1. All Goldcorp entities making cash, time or in-kind contributions will develop and maintain a transparent and accountable procedure for reviewing, selecting and administering funding requests and payments. This process will be managed through a designated multidisciplinary group or team.
2. Goldcorp sites and offices are required to record community contributions. Goldcorp's corporate head office will be responsible for compiling data logged throughout the company and reporting on Goldcorp's global community contributions in our public Sustainability Report to ensure transparency and accountability.
3. Goldcorp will provide support for initiatives within Goldcorp's area of influence which are inclusive of and don't discriminate against any gender, age, ethnic origin, religion, education, sexual orientation, political belief or disability. Goldcorp promotes contributions

to entities that will benefit groups, rather than individuals, and will not support initiatives dedicated primarily to the advancement of religious interests.

4. Goldcorp will collaborate with partners wherever possible to ensure the continuity and sustainability of community contributions benefits and minimize dependency on Goldcorp's operations once the mine has closed.
5. Community Contributions will respond to locally-identified goals and priorities that also support Goldcorp's strategic objectives. To evaluate whether our contributions are meeting these goals and adding value for all parties, Goldcorp will work with community partners to identify the intended outcome of all initiatives and monitor the outcomes and impacts of our material contributions. Goldcorp will hold beneficiaries accountable to report back on the outcomes and impacts of our contributions.
6. Goldcorp's community contributions are focused in our key subject areas, which are a) Arts, Culture & Recreation, b) Education, c) Local Economic Development, d) Environment, e) Health, f) Governance, and g) Diversity. Goldcorp aligns these categories of contribution with the global Sustainable Development Goals (SDGs) to support their implementation and enhance our commitment to the UN Global Compact.
7. Goldcorp will ensure that any requests for contributions to government entities or officials are addressed in accordance with the Government Payments and Contributions Policy. Any contribution made directly or indirectly to political parties, politicians or candidates for public office, should follow Goldcorp's Political Contributions Policy.
