Toronto, Ontario, February 17, 2026 – CT Real Estate Investment Trust (“CT REIT”) (TSX: CRT.UN) announced today that the trustees of CT REIT have declared a distribution for the period of February 1, 2026 to February 28, 2026 of \$0.07903 per trust unit, payable March 16, 2026 to unitholders of record on February 27, 2026. This distribution, if annualized, would represent a rate of \$0.94836 per annum.
