In 1990, he joined Central and South West Corporation (CSW) as Assistant Treasurer and later held positions in CSW Energy, and Regulatory Services. Following CSW's merger with AEP, he served as a Director in Mergers and Acquisitions, and Commercial Operations. His utility experience of more than 30 years also includes corporate planning and forecasting, regulatory, fuels, power generation development and accounting.
